# QUALIFICATIONS FOR THE PRESIDENT OF THE UNITED STATES (Partisan Candidate)

Before the filing officer accepts a declaration of candidacy, the filing officer must read the constitutional and statutory requirements to the candidate or the candidate's designated agent, and the candidate or the designated agent must state whether the candidate fulfills the requirements. If the candidate or the designated agent indicates that the candidate does not qualify, the filing officer shall decline the declaration of candidacy. Refer to Utah Code Annotated § 20A-9-503

#### **QUALIFICATIONS FOR OFFICE**

United States Constitution, Article II, Section 1

- Natural born citizen of the United States.
- 35 years of age upon taking the oath of office
- Resident of the United States for 14 years upon taking the oath of office.

Utah Code Annotated § 20A-9-803

- Identify the registered political party whose nomination the candidate is seeking.
- Provide a letter from the registered political party certifying that the candidate may participate as a candidate for that party in that party's presidential primary election.
- Pay a filing fee of \$500.
