UNAFFILIATED CANDIDATE CERTIFICATE OF NOMINATION PETITION

WARNING: *It is a class A misdemeanor for anyone to knowingly sign a certificate of nomination signature sheet with any name other than the person's own name or more than once for the same candidate or if the person is not registered to vote in this state and does not intend to become registered to vote in this state before the county clerk certifies the signatures.*
