# Utah Presidential Electors Certification

Each registered political party shall select presidential electors and fill vacancies in the office of presidential elector for their party's candidate for president. The submission of electors and alternatives shall include the name, address, and phone number for each person. The deadline to submit that information to the Lieutenant Governor's office is no later than 5 p.m. on August 31.

Unaffiliated candidates and write-in candidates are required to submit their electors no later than 5 p.m. ten days after the day on which the candidate files a declaration of candidacy. A candidate shall certify the names, addresses, and phone number of each individual selected by the candidate as a presidential elector for the candidate and the names of alternatives to fill any vacancies.
