**2024 General Election**

The Board of Canvassers of Rich County, Utah, met at the County Courthouse, 20 S. Main Street, Randolph, Utah, at 10:00 a.m. on Monday, November 18, 2024, to conduct a canvass of returns from the November 5, 2024, General Election pursuant to Utah Code Unannotated 20A-4-304. The following members were present, constituting a quorum:

Jonathan Lee,    Commissioner

Anneliesa Peart, Clerk-Election Official

Anneliesa Peart conducted the canvass. A cursory review of the ballot tabulations was made. The results of the canvass are attached.

Mrs. Peart stated that 1472 ballots were cast during the November 5, 2024, General Election, and 1465 ballots were processed.

The number of ballots received by mail totaled 1363, the number of military and overseas (UOCAVA) ballots totaled seven (7), and the number of ballots received in-person totaled fifty-six (56), four (4) ballots were received by mail, post-marked after November 4, 2024. There were thirty-nine (39) voted provisional ballots. After counting the 1363 by-mail ballots, the fifty-six (56) in-person ballots, the seven (7) UOCAVA ballots, the thirty-nine (39) provisional ballots, and rejecting six (6) invalid ballots, the percentage of ballots counted was 100%, for a total of 1465 ballots counted.


The number of ballots counted pre-election night was 1137. The number of ballots counted on election night was 283 for an election night voter turnout percentage of 17.85%. The number of ballots counted post-election night was forty-five (45), constituting a total number of ballots cast at 1465.

Mrs. Peart reviewed the audit procedures with the Board. Rich County was required to audit fifty-one (51) ballots, which the Lieutenant Governor's Office randomly selected. The fifty-one (51) chosen ballots were verified using a hand-tally count, and all the votes were visually verified and passed. Additionally, sixteen (16) voter signatures were audited separately—constituting a 1% audit—and successfully passed.

Election Official, Anneliesa Peart, followed all the noticing and reporting required by Utah State Code.

MOTION: Jonathan Lee moved to accept the results of the 2024 General Election as submitted by the Clerk-Election Official. William Cox seconded the motion, and the vote carried unanimously.
